Conditions and declaration

1. Each of trustees (or directors of the trustee company) does not employ any of the other trustees (or directors of the trustee company), unless they are related.

2. If trustee is a company, director of trustee must make one of following declaration:
 - a. "We are / I am unaware, or have no reasonable grounds to suspect, that a person who is , or is acting as, a responsible officer of the trustee is a disqualified person as defined in section 120 (1) of the superannuation Industry (Supervision) Act 1993. "

 - b. "We are / I am aware, or have reasonable grounds to suspect, that a disqualified person is, or is acting as, a responsible officer of the Trustee. However, we / I believe that person is eligible *(under subsection 126B(1) of the Superannuation Industry (Supervision) Act 1993) to apply to the Regulation for a declaration waiving his or her status as disqualified person and that the person will make an application under subsection 126B(3) within the allowed period. "
